

Student Research Symposium Draws Crowd



Albertus Announces 2008 Honorary Degree Recipients

The Board of Trustees of Albertus Magnus College has voted unanimously to confer the honorary degree of Doctor of Humane Letters upon the following distinguished individuals at the College’s 85th Commencement Exercises, Sunday, May 18:

Charles G. Crump—After service during World War II, Charles Crump returned to his native Connecticut and began a career in the brokerage business at Charles W. Scranton & Co. in New Haven, where he rose through the ranks to managing partner. Now a senior investment adviser and research analyst with Stephens, Inc., he has given to his hometown of Wallingford many years of volunteering to local organizations, including the school board and fire commission.

Carlton L. Highsmith—Founder, president and CEO of the Specialized Packaging Group, Inc., the largest minority-owned business in Connecticut, Carlton Highsmith is an innovative entrepreneur and passionate philanthropist. Headquartered in Connecticut, his company has manufacturing sites, design centers and sales locations in 10 locations in the U.S. and one in Canada. He is a steadfast advocate for the “endless possibilities” education provides to young people.

Thelma M. Johnson—Thelma Johnson has spent nearly 50 years in the field of education as administrator, college professor, reading specialist and public school teacher. Consulting regionally and nationally, she has focused

on ways to help teachers make a student’s learning experience the best it can be. Dr. Johnson brings the same spirited commitment to her personal philanthropy and to her numerous civic and public service activities.

Valerie F. Lewis—From November 2000 to February 2008, when she retired, Valerie Lewis served as Connecticut’s Commissioner of Higher Education. She has been a strong advocate for controlling tuition costs and increasing aid and access for needy students, and has held a variety of public and independent college administrative positions in admissions and financial aid, and in finance. She will deliver the Commencement address.

Jacqueline Noonan, AMC ’50—A chemistry major at AMC who also earned her medical degree at the University of Vermont, Dr. Noonan went on to achieve a long list of firsts in her medical teaching career, as well as an international reputation for her pioneering work in pediatric cardiology and the causes of congenital heart disease. Today Noonan Syndrome is recognized as one of the most common syndromes associated with congenital heart failure. She is professor *emerita* of pediatrics at the University of Kentucky College of Medicine.

- On April 17, Dr. Julia M. McNamara joined U.S. Catholic college and university presidents invited to Washington, D.C., to attend a talk by Pope Benedict XVI on Catholic higher education. The address took place on the campus of The Catholic University of America. She also attended a reception at the Embassy of Italy in honor of the 81st birthday of Pope Benedict.
- Dr. Howard Fero, assistant professor of management and leadership, and director of the Master of Arts in Leadership program, has been elected to a two-year term as president of the Institute of Behavioral and Applied Management. IBAM is a network of college and university professors studying the field of management, practitioners in business and the corporate world, not-for-profit organizations and government, and students.
- New Haven Business Times earlier this month honored Bernadette Holodak, director of development, as one of its Twenty Noteworthy Women. A 2006 graduate of the Greater New Haven Chamber of Commerce's Leadership Center program, she is vice president of the board of the New Haven Literacy Volunteers and chair of its annual Scrabble Tournament; she was volunteer of the year in 2004 at Hopkins School; and she volunteers for the American Cancer Society.
- Evie Lindemann, clinical coordinator for the Master of Arts in Art Therapy program, served as research associate, coping skills trainer and project director for Dean Margaret Grey of the Yale School of Nursing, the principal investigator for a seven-year project testing the application of coping skills training with children, teens and families with type 1 diabetes. Lindemann worked on the randomized clinical trials that began with adolescents. The National Institutes of Health and the National Institute of Nursing Research (NINR) recently named the first of Dr. Grey's studies with adolescents as one of 10 landmark studies in NINR's 20-year history.
- Stephen Steinlight, fellow at the Center for Immigration Studies in Washington, D.C., spoke on "Immigration, Immigration Policy and the 2008 Election." The Master of Arts in Liberal Studies program sponsored the talk, which was open to the College community.
- The College's Accelerated Degree Program sponsored Leadership Greater New Haven's Second Annual Alumni Reception January 30 at Business Expo 2008. Dr. Howard Fero, assistant professor of management and leadership and director of the Master of Arts in Leadership program, served as moderator for the panel on leadership and community service. Panelists were Charles Frey, president and CEO, American Red Cross of South Central Connecticut; Kristin Geenty, president, The Geenty Group; and Tony Valillo, president, The United Illuminating Company.
- On April 11, there was a noon-time reception and book signing for the College community at Rosary Hall to recognize four faculty members whose books have been published recently. The authors are: Susan Cole, "Missing Alice: In Search of a Mother's Voice," Syracuse University Press, 2007; Michael Geary, "Sweet Land of Security," YBK Publishers, 2008; Elise Martucci, "The Environmental Unconscious in the Fiction of Don DeLillo," Routledge, 2007; and Paul Robichaud, "Making the Past Present: David Jones, the Middle Ages, & Modernism," The Catholic University Press of America, 2007.

New Award Honors Betsy Fahy

Director of Athletics Jen Pacelli, inspired by a passage in Elizabeth Kubler Ross's "Life Lessons"—"With those who have died, we find new ways to share their existence as they live on in our hearts and memories"—has established the Betsy Fahy Award to be given to a student-athlete who exhibits passion for his or her sport, a spirit of camaraderie toward teammates and opponents, and a jovial disposition. The award honors the late Betsy Fahy, who had just completed her eighth season as coach of the women's tennis team when she died in June 2007 after a short illness. The award will be presented during the athletic awards ceremony held every spring; this year's event is May 1.

A graduate of Marymount College, Fahy received graduate degrees from Fairfield University. A tennis pro for many years at the Owenego Beach and Tennis Club, she was a retired teacher and vice principal who served the Milford (CT) School System for 35 years. Fahy was the daughter of the late Mary Catherine O'Brien Fahy '29 and the niece of Helen O'Brien Levack '32.

2008 Alumni Awards

- Add a Premier Achievement Award that is presented to an individual who has graduated within the last 10 years. This award can be presented to more than one alumna/alumnus.

Alumni of the Year

Joan Lucey Donnelly '58

Over the years, Joan has been very involved with organizations advocating the full inclusion of persons with disabilities into the day-to-day life of the Catholic Church and society. For 38 years she has been a member of the Robert Brunner Foundation and is currently vice president; she also serves as president of CUSA—An Apostolate of Persons with Chronic Illness and Disability; and she recently became a member of the Board of Governance and treasurer of the National Catholic Partnership on Disability. Joan Donnelly played a leadership role in planning the Class of 1958's 45th reunion and is currently spearheading its 50th reunion donation drive.

Patricia Scussel '89

Patti Scussel is executive director of the Greater New Haven Leadership Center, which offers programs for potential and current leaders in the area, including Leadership Greater New Haven, a community development course emphasizing leadership training within the framework of critical and social issues, and Executive Orientation for senior-level executives who are interested in understanding the area's critical issues. She also serves as executive director of the New Haven Network for Public Education. Passionate about the importance of volunteering, she is a member of numerous boards and committees, such as the Connecticut Consortium of Education Foundations, Connecticut State Scholars' Business Support Committee and The Community Foundation for Greater New Haven's Fund for Women and Girls.

Premier Achievement Award

This new award honors an individual who has graduated from the College within the last 10 years and who has excelled either professionally, within the community or shown extraordinary loyalty and dedication to the College. This award can be presented to more than one alumna/alumnus.

Jodi Lombardozi Everone '02

In her first year of graduate study at Southern Connecticut State University, Jodi received the Connecticut Department of Mental Retardation's John F. Shaw Scholarship, which honors one graduate student in the state who "shows a commitment to integrating those with intellectual and developmental disabilities into mainstream society." Today she is a speech-language pathologist in the public schools of Stratford, Connecticut, providing speech and language therapy to students who qualify for special education services. In her work, breakthroughs with students are few and far between, but when they do occur she knows she has made a difference that could have an impact on the child's education and adult life.

Terri Smith '05 MSM, '06 MBA

After retiring from the corporate world, Terri Smith began her graduate work at Albertus. She is now director of the Urban Outreach Program for the National Kidney Foundation of Connecticut, creating the only program of its kind in the country. She brings word about kidney disease to minority groups around the state—particularly the African American community, which has an extremely high risk of developing the disease. She combines traditional media with out-of-the-box thinking to reach her audience. In January 2008, the Hartford Business Journal honored Terri Smith as its Health Care Hero for community service and her pioneering work in educating and empowering minorities to find and use existing health care resources. Every day her efforts help save lives.

In 2007 U.S. News and World Report included speech-language pathologist is its listing of Best Careers. It didn't surprise Jodi Everone at all. This speech-language pathologist knows she has a great job.



"I love the versatility my career offers. I can work with infants or adults, in a hospital setting, private practice or in a school system," she says. Her choice: working in the public schools of Stratford, Connecticut. "It can be a challenge. There are so many state and federal special education laws to follow when providing students in the schools with speech-language services. Maintaining a positive working relationship with students' parents and collaborative professionals is sometimes a challenge as well, but it's absolutely essential for student success."

Her role in the town's schools is to provide speech and language therapy to students who qualify for special education services. She evaluates speech and language disorders in children, and creates individualized education plans, which include curriculum-related goals and objectives, for students who have been diagnosed with speech-language disorders. A good portion of her work involves providing strategies and consultations to classroom teachers who have concerns about their students' speech or language skills.

Everone traces her interest in the field to her undergraduate days at Albertus. Through internships she began working as a behavior therapist with autistic children. "I really enjoyed the one-to-one setting and providing skill training to children with disabilities," she recalls. Working with a speech-language pathologist at one of her internships, she began to understand how direct instruction of language skills from a qualified pathologist could have an impact on a child's education and adult life.

In her work, breakthroughs with students are few and far between. But when they do occur, she knows she has made a difference. "It's the most rewarding part of the job," she says. "Having a parent tell me that a child is using a skill at home that we worked on so hard and so long at school...that is the most wonderful feeling and most rewarding experience in my line of work."

At Albertus, Everone majored in communications with a double minor in sociology and psychology. She was class president as a freshman and sophomore, vice president as a junior; in senior year, she was president of the Student Government Association. In her first year of graduate study at Southern Connecticut State University, she received the Connecticut Department of Mental Retardation's John F. Shaw Scholarship, which honors one graduate student in the state who "shows a commitment to integrating those with intellectual and developmental disabilities into mainstream society."

In addition to her master's degree in speech and communication disorders, Everone has taken 30 credits of graduate level course work in assistive technology, which provides specialized training in educational computer software, hardware and alternative communications devices. She also holds professional certification of clinical competence from the national American Speech-Language Hearing Association.

Thoughts on Albertus

I receive a copy of From the Hill regularly and am always disappointed that none of my classmates have kept in touch. Then I realized, neither did I, so since I will be unable to attend my 30th Reunion, I am sending an update as to what I have been doing.

It's hard to believe it has been 30 years since graduation. I moved from Connecticut to Georgia 11 years ago to accept a new position with the company I was working for, DuPont Sorvall. Since then the company name has changed three times and is now Thermo Fisher Scientific, the largest manufacturer of life science equipment in the world. I manage the sales of biomedical research equipment to academic accounts, the government (e.g. CDC, USDA) and the private sector (pharmaceutical and industrial). Originally my territory was Georgia, Florida, South Carolina and Alabama, but we now sell so many products I only cover the state of Georgia and 25 sales reps.

In addition, I own a 50-acre horse ranch called Rockin' Lorado where I own six horses (and one due to foal in May) and board another nine. I handle all the maintenance of both the property and the horses. I am also a partner in a small shop in town called Sweets Treats n' Eats, which is a cross between Starbucks, an old fashioned candy store and a sandwich shop. I do some of the baking, handle the books, make the gift baskets and occasionally wait on customers. I live on the ranch in a four-bedroom house with my 80-year-young Dad, who moved down from Connecticut four years ago, and my seven dogs (all rescue animals) Dexter, Sam, Penny, Bear, Honey, Candy and Lady.
